## A REVIEW OF EXISTING CALIFORNIA STATE DATA ON EDUCATION

### INTRODUCTION

This report is a review of the data currently gathered and disseminated on the state level for K-12 public schools in California. It is one of four reports which together comprise the Poverty and Race Research Action Council's (PRAAC) state data reconnaissance project, coordinated by the California Budget Project (CPB).

The education portion of the report was gathered by Policy Analysis for California Education (PACE), a nonpartisan education research center affiliated with the Schools of Education at the University of California at Berkeley and Stanford University.

This report is designed as a data guide for researchers and policymakers regarding the kind and quality of education data available.

The catalogue section of this report outlines state level data: raw data sets and published reports and compendia available through state, federal and non-governmental agencies. At the end of the catalogue section of the report, there is a matrix supplied to demonstrate what particular data are collected by specific sources. Three appendices also are included to explain specific data sets in more detail.

### STATE DATA SOURCES

California collects a wealth of K-12 education demographic and financial data. The information is easily obtainable and available in several forms. Most

divisions of the California Department of Education, for example, have the internal capacity to collect data pertaining to their particular programs. During the 1990's, the state has made an effort to bring sources of data together to provide central locations for data dissemination. An important additional component of that effort, the California Student Information Service, is seeking funding for a pilot year of operation in 1996. CSIS will be an effort to provide one central source for much relevant educational data culled from many different divisions within the Department of Education and other state agencies.

The following section lists state level data collected by the state of California.

#### **DATA SETS**

The following lists raw data collected by the state.

##### *California Basic Educational Data System (CBEDS)*

*Description:* CBEDS is a single annual collection of data about school staff and enrollment in California. The purpose of CBEDS is to satisfy the California Department of Education's (CDE) continuing need for data for reporting purposes as well as to inform program management and planning. The system is designed to allow the data to be combined in many ways to serve various purposes identified by the Department. The data are self-reported by school principals, teachers, and other school district personnel. (See Appendix A). CBEDS is updated annually.

CBEDS data are also used to compute: 1) funding for grades 9-12 instructional materials, 2) certificated employee ratios, 3) funding limits for special education, 4) allocation of federal funds for vocational education, and 5) funding levels of other categorical programs. Additional uses of CBEDS data

include projection of future enrollments, counts of vocational education staff and students to fulfill federal reporting requirements, and listings of curriculum offerings and course enrollments. Local district needs can also be served by CBEDS data in the area of class load analysis and studies of staff comparability among schools.

### California Student Information Services (CSIS)

*Description:* The California Student Information Services was initiated in 1992 as a project designed to collect and share student data from a variety of divisions within the California Department of Education. CSIS has applied for funding for a pilot year (1996), but to date has not been fully funded and is not yet operational. The goal of CSIS is to improve the quality and transmission of student data and to make the data more uniform, comparable, accurate, timely, and accessible.

California's efforts are being coordinated with national efforts aimed at improving student data sharing among states and the U.S. Department of Education. This system will fold in demographic and financial data collection, such as CBEDS, to collect data in the following broad categories:

- Assessment
- Compensatory Education
- Research, Evaluation and Technology
- Child Development
- Vocational Education
- Special Programs
- Education Finance
- School Facilities
- Healthy Start
- School Crime Reporting

CSIS collects a total of 54 reports from local education agencies around the state (mostly individual schools and districts) (see Appendix B). If full funding is obtained, the majority of the data included in CSIS is to be collected annually.

The drawback of CSIS is that although a wide variety of data are readily available, the data cannot be cross-referenced (i.e., to consider the number of students in the gifted and talented program who also may be in a bilingual program).

### *Racial or Ethnic Distribution of Staff and Students in California Public Schools, 1993*

*Description:* This is an annual report of CBEDS data focusing specifically on enrollment in public schools by racial and ethnic group. Racial and ethnic group distributions are available by county, grade level, and gender. The report also details the number of twelfth grade graduates by county and racial

or ethnic group, as well as the number of teachers and other certificated staff by county and by racial or ethnic group. Finally, the report also provides a comparison of racial or ethnic distribution in enrollments by county over selected years beginning in 1977 as well as a comparison of public school population with total state population by racial or ethnic group for selected years.

Language Census Report

*Description:* The California Department of Education collects Language Census data as required by Education Code sections 62000 and 62003. The census reports languages spoken by all K-12 students. This annual report is presented by county and language spoken. It is also possible to secure data from the census regarding specific schools, school districts and grade levels. These are self-reported data collected from school districts and collated in Sacramento.

### California Statistical Abstract (1994)/Department of Finance

*Description:* The education section of the statewide statistical abstract summarizes data relating to public and private education at both the K-12 and higher education level. The K-12 information is gathered from the Department of Education. The higher education information is gathered from the Department of Finance and the California Postsecondary Education Commission.

Within the Abstract there are two particularly important tables (noted below).

These supply some of the same information as CBEDS, however the data are longitudinal:

Table F-3 summarizes: number of public school districts, number of public and private schools, fall enrollment (public and private),

number of full-time teachers (public and private), number of graduates. The listing is from 1987-1994.

Table F-4 summarizes enrollment K-8, high school, special classes, adult classes from 1984-1994 as well as the number of school personnel, teacher and non-teaching. Average daily attendance, state apportionments, revenue receipts by source (1986-1994).

The information is updated annually.

*Goldmine/California Department of Education Online Services*

*Description:* The California Department of Education has CBEDS information, as well as some additional data available online. The Goldmine is a file transfer protocol (ftp) server. Most dial-up Internet services point to the gopher site as California Department of Education within their EDUCATION or GOVERNMENT directories. There is a World

Wide Web site that is being developed as well, but it does not to date contain all of the files available by the ftp server.

The FTP Directories contain demographic breakdown of California K-12 school data in the following categories:

- Enrollment numbers and type of district
- Number of Schools
- Year round schools
- Number of students by grade
- Enrollment by ethnic group
- Enrollment by gender
- Graduates by ethnic groups
- Percent of attrition by ethnic group vs. graduates

- Drop-out rates statewide by ethnic group and by gender from 1991-94.
- Number of Limited English Proficient students by language breakdown and by percent of enrollment.

The FTP directories also contain Fiscal Forms reporting on the general fund, program cost accounting and current expense formula/minimum classroom compensation. The fiscal data are available to download in four self-extracting data files.

\* Drop-outs: Single year drop-out rate (vs. for the last 8 years the Department of Education has used a "derived" drop-out rate, calculated for grades 10-12, reported as estimated for each graduating class but based on all four years divided by 4). It could not be used to compare California to other states. In 1991-92 California expanded statistics on drop-outs to include grades 9-12 vs. 10-12. It is now comparable to other state drop-out rates.

The site also contains some information about curriculum, test scores, libraries, publications, the Education Code as well as laws, regulations and evaluation of programs of the Elementary and Secondary Education Act (ESEA).

The demographic information is updated annually.

### DATA SETS AND REPORTS

The following data sets are a rich source of information that can be aggregated to a state level. Various reports on specific subjects that have been compiled from the data sets are also included.

#### *Common Core of Data/National Center for Education Statistics*

*Description:* The *Common Core of Data* is a massive data set collected nationally containing principally demographic data.

The *Common Core of Data* has already been discussed in the federal study of education data completed for the Poverty and Race Research Action Council. More information on programs is available through the National Center for Education Statistics (located in the Office of Educational Research and Improvement within the U.S. Department of Education) and can be arranged by state subsample. It is also available on CD-ROM.

The *State Aggregate Non-Fiscal Report* includes information on all students and staff aggregated to the state level, including number of students by grade level; full-time equivalent staff by major employment category; and high school graduates in the previous year.

The *State Aggregate Fiscal Report* details data aggregated to the state level including average daily attendance; school district revenues by source (local,

state, federal); and expenditures by function (instruction, support services, and noninstruction) and subfunction (administration).

The *Schools and Staffing Survey (SASS)* is another study relating to schools that displays aggregated state level summaries. SASS is a mail survey of school teachers, school principals and school district administrators. There are four main components: Teacher Demand and Shortage Survey, School Administrator Survey, School Survey, and School Teacher Survey.

### *School District Data Book*

**Description:** The *School District Data Book* is an important information resource from the National Center for Education Statistics within the U.S. Department of Education. It marries NCES/CCD information with Census Department data. The data book displays data by state.

Data record types include:

- all households
- all persons
- households with children
- number of parents living with children
- children's households characteristics
- children's parent's characteristics
- children's own characteristics.

Database items can be cross-referenced to combine demographic information about schools and students. This can be combined with NCES/CCD financial expenditure information to give a picture of which students are served by different available programs.

### *Compendia*

The following are some important sources of easily accessible federal data that has some relevant state information.

#### *The Digest of Educational Statistics*

*Description:* Published by NCES, this is a compilation of statistical information covering the broad field of American education from kindergarten through graduate school. The *Digest* is divided into seven chapters:

- All Levels of Education
- Elementary and Secondary Education
- Postsecondary Education
- Federal Programs for Education and related Activities
- Outcomes of Education
- International Comparisons of Education
- Learning Resources and Technology

Much of this information is available on a state-by-state basis.

#### *Green Book/House Ways and Means Committee:*

*Description:* The *Green Book* from the House Ways and Means Committee supplies a large variety of financial and demographic data. That which pertains to education and is broken out by state is related to information on numbers of children served by school lunch programs.

The *Green Book* also has selected economic, population, immigration, income and fiscal data for the U.S. on a state-by-state basis. Although these

data are not specifically geared toward education, they would be of use for some education research purposes.

The *Green Book* is available on CD-ROM or via Internet gopher.

### U.S. Department of Education State Profiles Book

*Description:* This book aggregates state level demographic and financial data. It lists the number of students, teachers, expenditures on a state-by-state basis. This information is available through the Common Core of Data, however the *State Profiles Book* is a convenient way to locate data by individual state.

*Description:* This report compiles information on current issues in California education and presents them within the context of major policy developments in the state. *Advisory Commission on Intergovernmental Relations (ACIR)*

*Description:* The ACIR publishes several volumes which include state level education information. *The Structure of State Aid to Elementary and Secondary Education* (December 1990) is an explanation of state-by-state funding mechanisms for schools.

*Significant Features of Fiscal Federalism, Revenues and Expenditures, 1994* displays state-by-state revenue and expenditure patterns. This volume includes expenditures for both elementary and secondary education.

*Survey and Analysis of Salary Trends 1994/American Federation of Teachers*

*Description:* This survey of teacher salaries is available by state. The first section consists of state comparisons of salaries. The second section shows trends in national averages of teachers' and other workers' salaries over a 20-30 year timespan. The third section focuses on beginning teachers, with supplemental information on experienced teachers reentering the profession and teacher retirement. The fourth section is an international comparison of teacher salaries and working conditions.

The research was conducted by the Research Department of the AFT in conjunction with state and local agencies. This report is particularly useful to compare like-sized districts throughout the United States.

**INTEGRATED SERVICES**

The following sources listed relate to integrated services which are the provision of social services to at risk students at the school site. The

information gathered pertain to income, health and demographic factors as well as the provision of services.

*Kids Count: Data Book. State Profiles of Child Well-Being/Center for Study of Social Policy 1990*

*Description:* This report provides state-by-state information on 10 indicators of child and adolescent health, education and social and economic well-being. Some of the data apply to K-12 education.

The indicators are:

- percentage of births with no early prenatal care
- infant mortality rate
- percentage of babies with low birth weight
- benefits as a percentage of poverty threshold
- percentage of children in poverty
- percentage no graduating high school
- teenage unemployment rate
- education expenditure per pupil

3 Year Evaluation of Healthy Start/SRI

*Description:* In California, this study is the only one of its kind evaluating integrated services efforts. SRI is also in the process of doing a 5-year evaluation of the Healthy Start program. Healthy Start is a state program designed to improve school success of children identified as high risk by providing social services through a network which is typically school based. Services at each site vary, however, they typically include mental health services, public health involvement (immunization, family planning) and education.

## CONCLUSION

There is a wealth of information about students, staff, facilities, and programs in California. The state goes to great lengths to provide adequate data for use by policymakers, researchers and the general public. However, there are a few substantial gaps. The following areas are lacking in quality information.

**Demographics:** Demographic information is available covering many categories of students, staff and programs. However, it is difficult to combine, compare and track data between categories within data sets of student populations. Consider for example, Chapter I students who are bilingual and are also special education students. Right now, CBEDS and CSIS (although still not operational) will count each individual within a category but cannot tell us who those students are who fit in multiple categories.

**Integrated Services:** Since integrated services are supplied by a network of providers, it is difficult to find data regarding consistent indicators of quality within each program. Each provider has different assessment protocol that has yet to be formed into an integrated data set. Some of that lack of data can be explained by the nature of integrated services programs throughout the state. The intent of the programs is to be family friendly and thus tries to reduce paperwork while processing the services. The existing data tend to be limited to numbers served across programs, rather than detailing the quality and extent of service in each area.

**Assessment:** Longitudinal information on student assessment in California is non-existent. There has been no consistent assessment of student performance in California since the late 1980's and the latest attempt at an

assessment system, CLAS, was defunded in 1994. There are other standardized tests given in districts throughout California, such as the California Test of Basic Skills, however those tests are not mandated or consistent across districts. Each district can choose its own standardized test and therefore may have its own longitudinal information, however that data cannot be aggregated to a state level. The state may once again institute a statewide student assessment mechanism, but has not done so yet.

**Teacher Supply and Demand:** The Commission on Teacher Credentialing (CTC) formerly reported on the number and types of teaching certificates issued in California. That information is still gathered, however it is neither summarized nor reported in terms of supply and demand any longer due to lack of funds. The system for gathering data is strictly an operational system to expedite the credential applications and cannot be used to predict supply and demand. However, CBEDS makes an attempt to collect data on demand in the County/District Information Form by asking about projected demand on a school-by-school basis. That information could be combined with CTC data to supply information about shortages and surpluses in subject areas as well as geographical locations around the state. However, to combine the information in order to produce reliable supply and demand data for the state, funding would be needed for additional programming and analysis work in order to provide clear teacher supply and demand information. Basically, all of the data exists now within the state government, just not in a form that can provide the necessary analysis. Note: The federal Schools and Staffing Survey from the National Center for Education Statistics (NCES) does a Teacher Demand and Shortage Survey that could potentially provide some aspects of state level data.

In sum, the California Department of Education makes a concerted and, in the face of continuing budget cuts, valiant effort to gather and analyze a great deal of data about the state's education system. However, as noted above there are some glaring gaps in information collection. Closing these gaps would enhance the ability of policymakers to make informed decisions.
